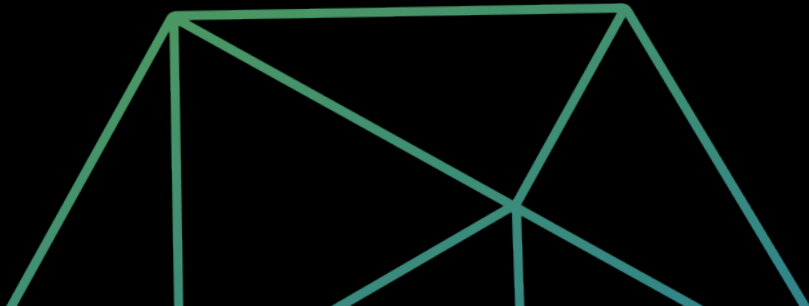

2.Tokenisation and Digital Assets:Tokenisation is gaining traction, particularly in money markets and collateralisation.

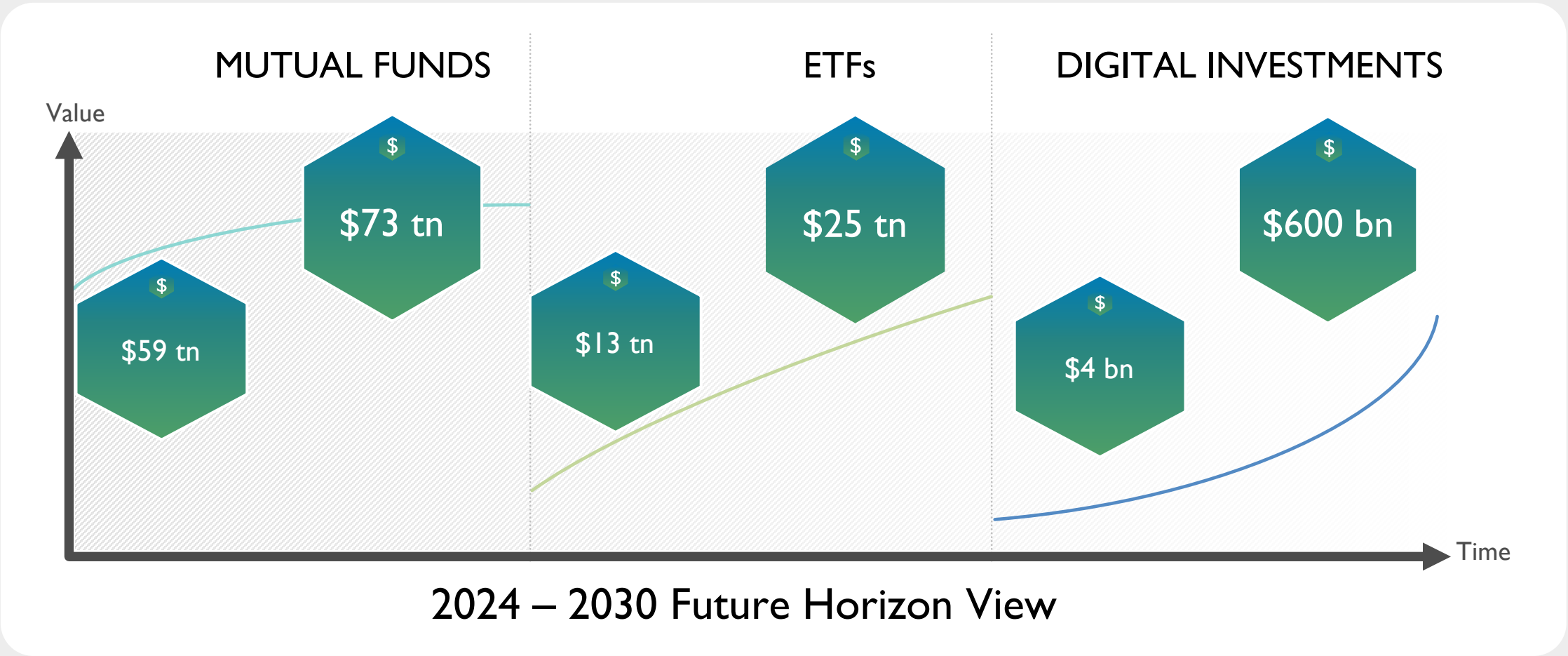
3.Growth of ETFs:Asia's Exchange-Traded Fund (ETF) market is expanding rapidly, outpacing global growth rates.

Vision

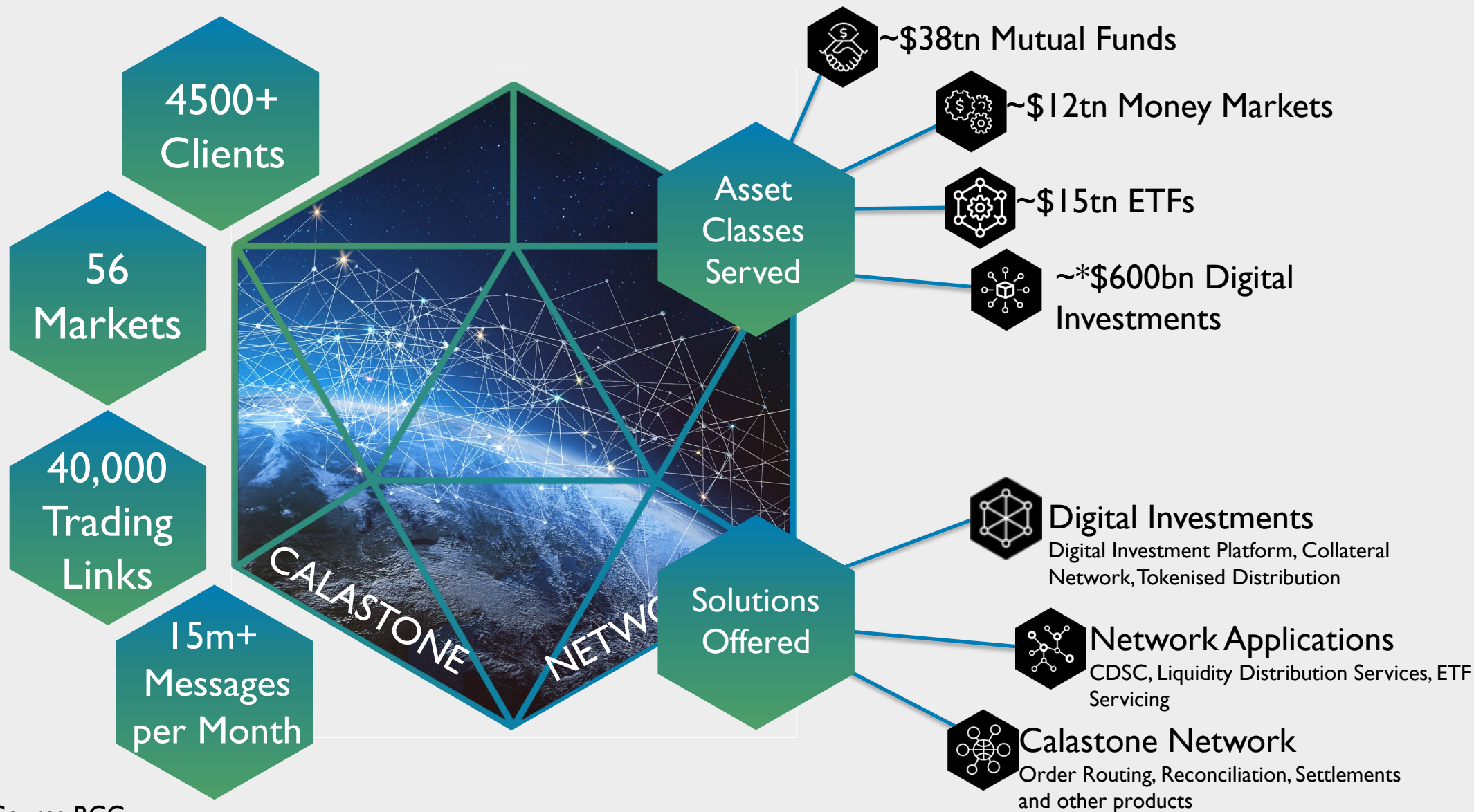
- Build a transparent and efficient digital ecosystem for fund services.
